I also confirm that the said Company/Firm would not purchase coal through Coal e-Distribution by Maharashtra State Mining Corporation Ltd (MSMC) during suspension / closure of the unit for any reason what so ever.

Any changes in the status of the Company/Firm at any point of time and/or linkage is granted by any nationalized coal companie(s) will immediately be informed and modified consumer profile will be submitted prior to any further participation in the Coal e-Distribution by Maharashtra State Mining Corporation Ltd (MSMC) .

That I further confirm that in case of any failure in complying with the undertaking mentioned in the preceding paragraph of Maharashtra State Mining Corporation Ltd (MSMC) / Service Provider shall have the right to cancel the order booked, forfeiture of EMD/Security deposit, cancel the registration or take further actions as per law.
