

GENERAL POWER OF ATTORNEY

(ON RS 100 STAMP PAPER DULY NOTERISED)

(For the period 1st of JANUARY, 2017 TO 31 st MARCH, 2018)

KNOW ALL MEN BY THESE PRESENT'S THAT

As my True and Lawful attorney in and empower him to do all or any of following acts and things for me and on my behalf that is to say-

1. To submit application, letter, documents for me and on behalf of my above stated unit.
2. To deposit the payment in the form of Demand Draft/ RTGS in respect of the monthly quantity of coal with MSMC Ltd. every month as per the notice displayed by MSMC LTD. Along with prescribed Bank Confirmation Certificate.
3. To Collect the delivery order issued in the name of my above stated unit / industry.
4. To submit the acknowledgement receipt (issued by MSMC Ltd) of coal lifted by my unit / industry in the previous month against the delivery order (Issued by MSSCF LTD) colliery acknowledgement with original truck loading passes / gate passes.
5. To sign the requisite documents on my behalf and to take the delivery of the Coal from the Colliery.

6. To collect the cheque from MSMC LTD. Against refund of excess payment , credit balance, if any.
7. To collect the bill from MSMC LTD.
8. To provide any information in respect of the procurement and consumption of coal as and when call by MSMC LTD.
9. To do all other lawful acts and things and deeds as he think fit and proper as fully and effectively on my behalf
